INVESTMENT: Per Formula

INVESTMENT: \$240 Base + \$75 for each additional partner or owner + \$15.00 per agent or associate.

(Base includes up to 5 full-time employees/associates and 1 owner/partner.)

SCHEDULE 3: Government Offices/Departments, Elected Officials and their offices and non profits with 100 employees or less

INVESTMENT: \$170 (Non-profits with more than 100 employees pay Base + \$3.00 for each additional employee over 100)
